Subclass 400

A short term, highly specialised work visa that allows work for up to six months for individuals to work on short-term projects.

Subclass 482

The temporary skills shortage visa that allows work for up to four years in specific occupations on the Skilled Occupation List. This visa requires an eligible sponsor.

Subclass 186

A permanent employer sponsored visa available to specific occupations after either a three-year period with the same employer two years. or obtaining a positive skills assessment.

Subclass 485

A temporary work visa that allows students to gain work experience following completion of their study for up to
